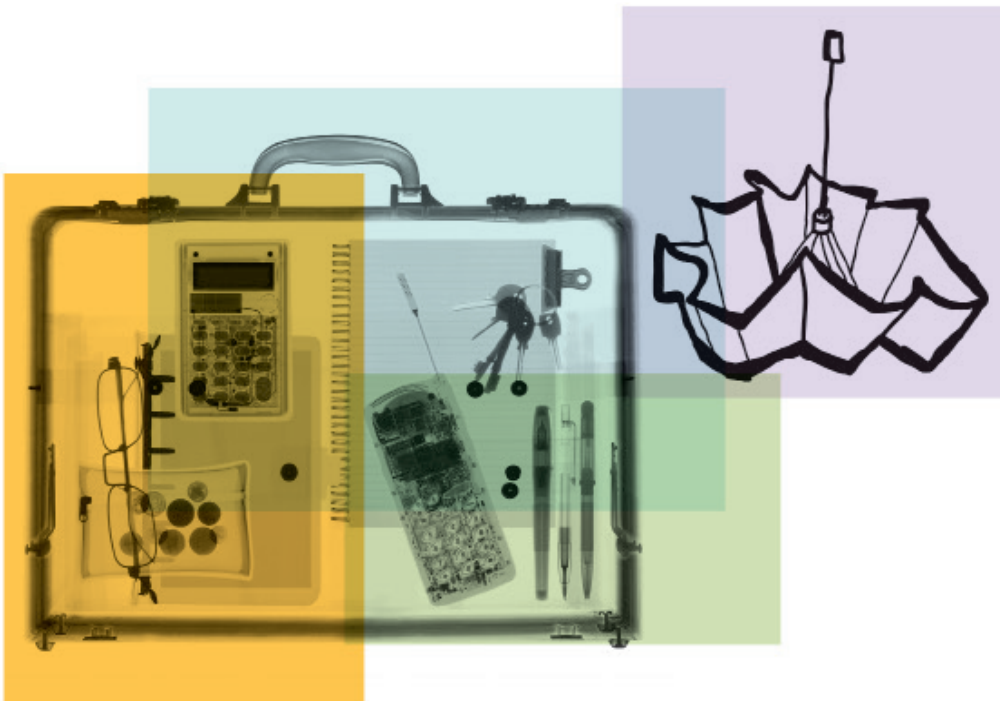
Training
