

In a sector where partnership working is crucial; this award is for an organisation, team or member of staff who has the strategic vision to recognise how working in partnership can improve the overall contribution to the customers and the communities that the organisation works with. The winning nomination will clearly evidence and showcase how partnership working has resulted in service delivery improvements, high levels of customer satisfaction, and overall, the positive outcome from a new/ improved way of working.

Our judges said:

"Shepway Community Larder was developed by Maidstone Borough Council and the West Kent Health and Care Partnership, to support local people with the challenges around food insecurity, the cost of living and other issues. The work of staff, volunteers, Fareshare and local food providers enables the Larder customers to do a 10-item food shop for a small weekly donation and provides support and information around housing and debt.

The Larder provides flexible responses to customer feedback, with high levels of satisfaction from the customers and positive outcomes. Testimonies show the customers value and appreciate the Larder, with many speaking warmly about the interactions with the staff and volunteers there. "

Dover Pantry Southern Housing Does your organisation support and provide the platform for projects within local communities to grow and thrive? Has a local communitybased project had such a positive impact on the local community that it needs recognition? This award recognises a project, person or group and there are no restrictions as to what the project outcome could be. Examples of previous winning projects include contribution to improving health and wellbeing, improving physical conditions and contributing to community engagement or projects that have positively addressed issues such as vandalism, anti-social behaviour and social inclusion.

Our judges said:

"Volunteers from mhs homes and their partnering contractors completely transformed a derelict garage into a much needed therapy room called Daisy Den, for the charity Dandelion Time. This farm-based, North Kent charity supports children affected by trauma and complex emotional difficulties.

The volunteers rose to a huge challenge, having originally anticipated only a little gardening!

They specified the work required, organised the labour and obtained donated building materials. This was different to the normal volunteer projects, taking place over two weeks rather than the usual day.

mhs homes were not only able to do something to support their customers but we were also able to provide support to families in the wider Kent area."

"The judges were impressed by this innovative, supportive community project in Medway. The project draws in women from all walks of life who can access a range of support and advice services, making them feel welcome and comfortable. Information is shared and services are promoted in a convivial setting. Everyone has a fun evening and the barriers come down. Women who have attended the project for a while feel empowered to start looking at providing services and arranging evenings for others, so the ripples spread wide."

Excellence in Development and Regeneration

Development of high-quality homes, on new sites or regeneration of existing places (urban and rural) can have a significant impact and make a contribution to meeting housing need, changing the perception of affordable housing and how well a community thrives. This excellence award will recognise the development of homes (new or refurbished) which can evidence this. There is no size criteria, the winning development won't necessarily be a large scheme, the key is demonstrating the achievement of meeting housing need and the provision of welldesigned and affordable homes, all delivered in a way that delights residents and the wider local community through excellence in design, construction or public realm.

Our judges said:

"In this category KHG wanted to see evidence of meeting housing need and the provision of welldesigned and affordable homes. The judging panel welcomed mhs's ambition to deliver more affordable homes to deliver a high-quality all affordable housing scheme and improve the energy efficiency of the new homes.

The impact of this was exemplified in feedback from a new mhs tenant: 'We are a family of 7 and therefore generally do 4-5 wash loads a day. I wasn't quite understanding how to make the best use of the solar panels. I contacted mhs who helped with this. Since then our electric usage has gone from £10 a day to £4. This will only get better throughout the summer months and I will manage my electric use as and when the solar is creating free energy."

Technology may have been central to your innovation but technology alone isn't essential. This award is not limited to the 'finished article', this is recognition of innovation and this could mean that it's a work in progress. The winning nomination will demonstrate how you've thought outside of the box to deliver with effective leadership and change, improving service outcomes as well as improving efficiency. The winner of this excellence award would have the opportunity to share learning and expertise to benefit other members of Kent Housing Group.

Our judges said:

"The Kent Housing Reciprocal Agreement is a collaboration between social landlords across Kent which aims to enable tenants to move to a safe area whilst retaining their tenancy rights. The judges were impressed by this innovative approach that puts the survivor at the heart of the services. Lisa led the project team for this work and they all recognise that without her drive and knowledge it may not have happened."

"Vicky has ensured that all social landlords across Kent and Medway have understood and prepared for the changes that were implemented in July. The skill, patience and scale of commitment Vicky has shown to implement this project while meeting the diverse demands of our providers has been amazing and the service for households and partners will be improved. Everyone wins! "

This excellence award will recognise an individual, team or organisation that can demonstrate that they have improved the quality or access to good private sector housing or services to the tenants and or landlords in this sector. The nomination could also highlight how activity in this sector has improved the health and wellbeing of tenants and/or provided additional quality rented homes to respond the local housing need, bringing longer-term benefits for all. Can you evidence this and what impact it has had upon your area of service delivery?

Our judges said:

"The dedication from the project team who successfully prosecuted a vicious landlord group working in their district is outstanding, the horrors described in the nomination highlights the commitment to ensuring good quality safe private sector housing. The four-week trial resulted in prison sentences, community orders and an order that the defendants pay £200,000 in costs, in addition the court successfully applied to the court to ban the defendants from engaging in letting or property management work or being landlords in England as well as applying for compensation for the victims.

The team have worked tirelessly since their creation in 2019, with this case alone highlighting their ability, dedication and determination to support good quality housing."

"We all know that the cost of living crisis is making this area of work particularly challenging yet this team have improved their already good rent collection rate, whilst halving evictions. They do this by matching their approach to each tenant, giving the support and advice they need to solve their problems. They have revised the way they work, including changing standard letters and the methods used to contact tenants, and the feedback from tenants shows the customers value the new ways of working."

Our judges said:

"The judges recognised how Mandy has overcome her own health issues to devote her time and energy to helping others. Mandy encourages residents to get involved and helps people tackle the daunting forms to claim benefits. She is a community champion, bridging the gap between residents, the community and mhs homes bringing people together to help influence, design and procure excellent services that meet their needs. Mandy's enthusiasm shines through and she provides an important voice for residents and encourages estate champions."

Our judges said:

"Paul has overcome his disabilities to devote his time, energy and enthusiasm to helping others. He transformed the communal garden space where he lives in Maidstone to create a lovely, welcoming garden for everyone to enjoy. Paul's efforts have encouraged his neighbours to come outside, socialise and enjoy the fresh air and garden space. This has helped to combat the feelings of loneliness and isolation that many people feel if living alone. Paul is a superhero bringing the pleasure of flowers and green spaces for his fellow residents to enjoy."

Excellent Young Professional of the Year

"Ellie's commitment to her role and her impressive, innovative approaches to her work have made a great difference to the organisation. Ellie is adept at building and maintaining professional relationships, is well respected and has made good progress in her career since she started.

Ellie made considerable savings for the organisation by halving staff sickness absence rates. In helping to improve call waiting times, Ellie has helped the organisation's reputation with customers. Ellie has had a positive influence on the management's way of working as well as helping to encourage staff to think of their mental wellbeing and ways they can access support."

About Kent Housing Group
