#### Stay #winterstrong

As the nights close in, Kent County Council (KCC) is sharing guidance to help tenants keep warm and well this winter. Vulnerable people, including the elderly, very young, pregnant mums and individuals with underlying health conditions, are at greater risk of becoming ill when it gets cold. But anyone can become sick because low temperatures weaken our immune system. This increases susceptibility to a range of health issues, such as cardiovascular diseases, and infections like flu and COVID-19.

Cold weather creates other health hazards. Using damaged appliances to heat a home increases the risk of carbon monoxide poisoning. Cold and damp housing is also more likely to suffer mould, increasing the risk of illness such as asthma. New quidance outlines what landlords should do to about damp and mould.

Heating one room to at least 18°c, wearing several layers, having hot food and drinks, and moving about, can all protect against illness – reducing the need for NHS treatment or a trip to A&E. Make sure tenants know about the **Priority Services Register** and cost of living help on kent.gov and GOV.UK. You can find out if a home is eligible for support for energy efficiency improvements through 'Help to Heat'.

#### DA reciprocal scheme off to a great start

A reciprocal scheme for social landlords to support households fleeing domestic abuse to retain a social housing tenancy is gathering real momentum.

Almost a dozen landlords have already joined the scheme and the first three families have been moved to a place of safety to rebuild their lives.

A working group held its first webinar in April and a second one was organised on 5 October for housing associations and local authorities who have not signed up yet.

The multi-agency initiative is being led by Lisa Clarke of Clarion Housing, who said: "We want to reduce the risk of homelessness for survivors. The scheme is helping landlords move survivors into another local authority area if they cannot find suitable within their own stock. The survivor will not lose their social tenancy.

The first family to benefit from the scheme moved into a home provided by mhs homes. We cannot publish details for the sake of the safety of the family but it involved moving them out of emergency temporary

accommodation into a house in another part of the county.

Leading the project was Sandra Paine, Customer Liaison Officer with mhs homes, who said: "The whole process was completed quickly and smoothly. It has been a very successful outcome and when I spoke to family recently they were delighted to be given the chance of a fresh start."

Brian Horton said: "As Chair of KHG I'm very proud to see the first results of collaborative working on a coordinated response to domestic abuse across the county to protect tenants and families at risk of homelessness. This exemplifies the convening role of KHG to make a positive impact."

#### EDI group makes progress

The latest meeting of our Equality, Diversity and Inclusion (EDI) group demonstrated how much momentum has been built up since the group was formed in the spring.

The Group – which is a safe space to discuss actions and share good practice, learning and ideas to address EDI across our member organisations – covered a range of topics, including a discussion of the Better Social Housing Review and to work on an action plan regarding race and ethnicity.

The meeting also had a presentation from Stonewall Housing on LGBTQ+ housing experiences. Future presentations are expected on gypsy, Roma and

traveller communities, the Armed Forces Covenant and Allyship – the lifelong process of people developing relationships and building empathy with marginalised groups to better understand their challenges and issues.

The EDI group has been formed in partnership with the Housing Diversity Network (HDN). KHG is an associate member of the Network, which acts in an advisory role to the EDI group. #### Making referrals safe, easy and secure

ReferKent is an online referrals system that organisations can access to make referrals for people who need more help than their organisation can give.

Since launching in September 2022, a range of organisations have joined, including

support services for mental health, gambling, fuel advice and much more. Every Citizens Advice Bureau across Kent are on-board too, making the ReferKent platform a unique tool for referring people to help and support in a timely way.

Organisations can just make

referrals through the system, or they can make and receive referrals. If you are regularly signposting and/or making referrals

#### Homes not stock

The Joseph Rowntree Foundation has provided a toolkit on how to talk about homes – you can view it here A framing toolkit: How to talk about homes | JRF

Key points include advice to talk about homes and not property or stock; and to recognise that homes are a way to protect health, not a form of wealth. As housing professionals we can often slip into talking about stock and a more 'human' tone can help us to better connect with tenants and the public. Previously JRF created a toolkit on talking about homelessness and it was considered a useful aid in achieving a better tone when writing documents relating to homelessness.





#### LET'S STAY FIRE SAFE

Partners are being encouraged to continue sharing the posters, social media posts and other materials in support of our ongoing "Let's Stay Fire Safe" campaign.

KHG has teamed up with a number of housing associations and councils to deliver the potentially life-saving campaign. It is split into two parts, covering fire safety advice in the home and guidance on keeping communal areas safe in blocks of flats.

Social housing landlords have been sharing details with their tenants, to encourage them to take simple steps to keep themselves, their families and neighbours fire safe. The campaign includes two animations (fully accessible with subtitle options), and a toolkit for landlords including images, social media assets and posts, QR codes, posters for communal areas and a dedicated KHG webpage.

Messages focus on the use of smoke detectors, not overloading electrical sockets, care if using any portable heaters, shutting fire doors in communal areas and keeping communal areas like corridors, entrance halls and stairwells clear from clutter.

#### RACE is on...

The Rural and Community Housing Enabling service (RACE) has commenced its survey programme

with the first undertaken in Chiddingstone, Sevenoaks – and unveiled its new logo and branding.

As we reported in the last issue, RACE has been set up by KHG and is being hosted by Ashford Borough Council and supported by contributions from councils and housing associations working across the county.

RACE works with communities to deliver housing that matches what local people need. It works with parish councils, housing teams at councils, housing associations and local developers to identify rural

> communities where action needs to be taken to meet the local housing needs.

Central to its work are surveys which it carries out aimed at the residents of individual villages and rural communities to find out whether there is a need for affordable housing locally.

#### **Asset Management**


We hosted the Impact of Damp and Mould event for nearly 100 attendees. It included presentations from key speakers and covered everything from its effects on health to the cultural aspects within the housing industry, and how we combat this issue with two product demonstrations. We had a presentation by KCC's Max Tant on flood resilience and one on how Dartford is utilising Vericon to gather data on property performance. Golding Homes' experiences with EV chargers was really useful, and can be shared with anyone who is interested.

#### Housing, Health and Social Care

Cedi Frederick, Chair NHS Kent & Medway, and ICB Director Malti Varshney explained the role of integrated care systems in reducing health inequalities. The group requires a Vice Chair and is keen to hear from anyone interested in this rewarding role.



#### Kent Homechoice

Westree Road Housing has joined the Kent Homechoice partnership. It was agreed to promote pre tenancy training videos. On the theme of affordability, it was agreed to update the website with new affordable home ownership schemes. Members heard that implementation of new system has provided greater transparency to the customer in terms of accessing available homes. They were also told that initial transitional issues after the new system went live on 1 July have been resolved.

#### Housing Strategy and Enabling

An event is to be arranged with HSEG, planners and developers to ensure closer working, to address concerns with the process of

ensuring the right type of high quality housing within sustainable communities are developed. Ensuring housing is resilient to future climate changes was discussed as part of the work. Thanet Council has delivered on an MMC site in Broadstairs - an Ashford MMC scheme is due to open next summer. An update from Homes England on its 2021-26 affordable homes programme led to debate about estate regeneration and replacement homes which are now included in the mix.

#### **Tenancy Management**

The group heard that members are continuing to use the marketing materials supplied as part of KHG's ongoing Let's Keep Fire Safe campaign, and will be evaluating the impact in a variety of ways. KCC provided an update on the Refer Kent service to help professionals make referrals, not signposting, for vulnerable clients.
